

## Preschool & Junior Kindergarten Agreement 2024-2025



**School Hours:** School hours are 8:30 to 2:30. Children can be dropped off in classes at 8:15 a.m. and picked up by 2:45 p.m. On-site daycare is available from 7:30 to 8:15 a.m. and 2:45 until 5:30 p.m. at \$5.00 per hour (rounded up to quarter hour.) Hourly rate after 5:30 p.m. changes to \$ 20.00 per hour (rounded up to nearest quarter hour.)

**Enrollment Fee:** To reserve a place in the Preschool or Jr. Kindergarten, a non-refundable fee of \$200 is required when the application is submitted.

**Materials fee:** A materials fee of \$200 per child is required and is due by August 1, 2024. If you enroll after these dates, the materials fee is due at the time of enrollment.

**Tuition payments:** Tuition is based on an annual fee. Payments are made August through May, due on the 1st of each month and late after the 15th of the month. The tuition is a contracted monthly installment. Illness, vacations, snow days/power outages, minimum days and school holidays do not affect the tuition cost. School holidays and minimum days are shown on the yearly calendar.

**Late Fee:** A \$50 late fee will be charged on all late payments after the 15th of the month.

**NSF Checks:** A check returned for non-sufficient funds will incur a \$35 charge. If a child withdraws from school before the end of a month, the entire month's tuition payment will be charged.

**Delinquent Accounts:** If, on the first of any month, there is a balance owed from the previous month, students will not be allowed to attend school until the prior balance is paid, or until a financial arrangement is approved by the Administrator, Business Manager, and/or School Board.

**Withdrawal:** If a family withdraws from Deep Valley Christian School before the end of the month, the full tuition installment for that month will be charged. If tuition has been prepaid beyond the current month, it will be refunded.

**Licensing:** The state licensing agency is free to make unannounced inspections of the facility at any time. Any complaints about the facility that cannot be worked out satisfactorily with the staff can be reported to the state licensing agency.

**Jr. Kindergarten:** This is a 5 day program from 8:30am -2:30pm. Tuition is \$ 540 per month.
